

What to Expect at TSFX "Head Start Lectures" and "Exam Revision Lectures"

The TSFX lectures have been designed to assist students to study in an effective and time efficient manner. The **"Head Start Lectures"** will help students get ahead in their studies. The **"Exam Revision Lectures"** will help students prepare for their examinations.

To derive the full benefits from our lectures, please consider the points and suggestions below.

1. We Do Not Believe in Superficial Overviews

To help you in your studies (and save you valuable time), you will be issued with detailed and comprehensive notes that address the topics being covered during our lectures, as well as important materials that will be addressed when you return to school. The notes will be sent via Australia Post and should arrive before the commencement of your lecture. Late enrollers will be given access to a non-downloadable electronic copy of the notes until their hard copy arrives.

To ensure that students receive the best head start for the forthcoming semester, teachers need to emphasise those sections of the course that carry the greatest weighting/importance. Therefore, your teacher(s) may skip sections of the notes as well as repeat style questions, and this is standard practise. We encourage students to work through these materials after the completion of the lecture – they are fully comprehensive, and include all the points that would have been discussed if these components had been covered during the lecture.

Note: If your teacher does skip a section that you would have liked to cover, please do not hesitate to clarify any questions during the designated question and answer times that are scheduled throughout the session.

2. Listen Carefully & Minimise Note Taking

The world's leading educational specialists agree that lectures/seminars are the best way of working through large amounts of information across a short period of time, as is the case when preparing for tests and examinations.

By using both audio and visual delivery vehicles simultaneously, it is possible to work through 5 times more theory and absorb 5 times more information than if you were to work through the same materials on your own.

The **benefits** of audio-visual based lectures are, however, **dramatically reduced** when students spend large amounts of time writing notes whilst simultaneously "listening" to the teacher and trying to watch the AV display. On average, those students who are only listening enough to convert the teacher's auditory/visual output into notes will only remember about 5% of what was presented!

In order to maximise your learning opportunities at our lectures (and further cut down on study time), we suggest that students spend as much time as possible listening, understanding and absorbing the information being delivered. Every student attending our programs is issued a detailed and comprehensive set of notes – meaning that all the theory that has to be committed to memory has been given to you. Do, however, copy down what the teacher has written on the AV displays, and jot down the various exam hints and suggestions that are delivered during each lecture, as these have not been included in the issued notes.

Note: Highlighting/underlining is a great way to help focus students and improve concentration during lectures.

3. "Head Start Lectures" - Do Not Be Concerned if You Do Not Grasp a Concept

Please do not be concerned or overwhelmed if/when your teacher addresses a topic that you are not familiar with or do not understand, as there are significant advantages to working through materials in advance of school.

Whilst other students **struggle** to understand the new concepts being delivered at school, you will be consolidating this information for the second time. Your **understanding** of examinable materials will be **greatly improved** – reducing the time you will need to spend preparing for assessments, whilst improving examination scores. Please do not be concerned or overwhelmed if/or when your teacher addresses a topic that you are not familiar with as there are significant advantages to working through materials in advance of school.

Your **understanding** of examinable materials will be **greatly improved** – reducing the time you will need to spend preparing for assessments, whilst improving examination scores.
