How many hours did you dedicate to study (outside school) across a typical week?

Monday to Thursday – 3-4 hours of study each night

Friday and Saturday off

Sunday – 3-4 hours

Question 10

What was your typical weekday routine?

Wake up at 7:30am → catch the bus at 8:10am → get to school at 8:25am → finish school at 3:06pm → get home at 3:35pm → start studying at 5pm – 6:30pm → dinner and a shower → study from 8pm – 10:30pm → sleep at 11pm - 11:30pm

I used a rough timetable of what I would do each day and allocated time fairly loosely to each task. I would reward myself after completion of tasks by spending time with family, friends, my boyfriend and pets. I also spent 45-60 mins, 3 times a week exercising.

Question 15

How did you approach the task of preparing for the exam? (For example, would you start the process by writing notes? If so, which resources did you use to compile materials etc).

For Economics and Legal Studies, I wrote notes summarising each topic. However, for English Advanced and English Extension One, I wrote practice essays and tried adapting a generic essay to different questions. For Mathematics and Mathematics Extension One, I did exercises from various textbooks and did past papers.

Question 16

How many hours did you dedicate to study (outside of school) in the weeks leading up to the exams?

From Monday to Thursday, I typically studied 4-5 hours each day. On Saturdays, I would study about 7-8 hours. However, on Fridays and Sundays, I would study about 1-2 hours but use them to take time off studying and spend time with family and friends.

Question 17

What was your typical day to day routine when studying for the exams?

My routine was much the same in the lead up to exams, except that I would go to the library after school and start studying at 3:30pm – 4pm. I came home at about 8:30pm, ate dinner, showered and would recommence studying at 10pm if I did not complete the tasks that I had set for myself. The latest I would sleep would be about 11:30pm.

Question 18

Did you continue your extracurricular activities in the weeks leading up to the exams?

I didn't continue extracurricular activities in the lead up to Trial examinations.

Question 19

Which technique(s) did you use to learn materials "off by heart"? (eg. writing notes, re-writing, reading texts etc).

English Advanced and Extension One: I memorised my essays as speeches then rewrote them a few times.

Mathematics and Extension One: I did many questions to memorise formulas.

Economics and Legal Studies: I reread my notes a few times.

Question 20

When did you start preparing for your TRIAL exams?

I started preparing for my trial exams about 4-5 weeks before they began.

Question 21

How much study did you engage in between the TRIALS and the final HSC exams?

English Advanced and Extension One: I made minor corrections to the essays that I had used in my trial examinations, if necessary, according to the marks and comments written by my school teacher and marker.

Mathematics Advanced and Extension One: I determined which topics I needed the most help in and did a variety of questions in these topics. Once I was comfortable with all topics, I did past papers from different schools and HSC Papers.

Economics: I memorised the key points of each topic and statistics relevant to each. Following this, I did questions from the Workbook and wrote practice essays.

Legal Studies: I memorised the key points of each topic and cases relevant to each. Following this, I did past HSC papers and wrote practice essays.

Question 22

Do you feel that you invested enough time into study between the Trials and the final HSC exams?

Would you have benefited from additional study across this period?

I believe that the Trial examinations drilled much of the information necessary for each subject into my head. However, the time spent studying in this period was valuable in solidifying this knowledge as well as correcting any mistakes that I had made in the Trials. I do not think that additional study would have benefitted me.

Question 23

Did your Year 12 peers at school invest in significant study in the lead up to the TRIALS?

My Year 12 peers invested enormous amounts of time into study in the lead up to Trials, essentially influencing me to also study harder.

Question 24

Did your Year 12 peers at school invest in significant study between the TRIALS and the final HSC exams?

The time between Trials and the HSC exams was spent with many of my peers, collectively studying to help each other achieve the greatest possible marks in the HSC examinations.

I feel as if the difficulty of the Trial Exams positively influenced my preparation for the HSC exams as they were in the same format, yet slightly more difficult, making the HSC slightly less stressful.

Although I was definitely stressed, I did not experience any anxiety attacks or mind blocks. A positive attitude and adequate preparation helped to prevent these situations.

Questions Relating to the Subject You Have Been Asked to Write About

Question 1

Which subject does this report relate to?

English Advanced, English Extension One, English Extension Two, Mathematics Advanced, Mathematics Extension One, Economics and Legal Studies.

Question 2

Based on your results and performance throughout the year, were you confident that you would obtain a Band 6 result? If not, what Band or overall mark were you anticipating/hoping to receive?

In English Advanced, English Extension One, Mathematics Advanced, Economics and Legal Studies, I was fairly confident that I would achieve a Band 6 result due to my consistently high marks in each assessment task. However, there was uncertainty about English Extension Two due to the external marking process and possible subjectivity in the allocation of marks. Also, I experienced difficulty in Mathematics Extension One throughout the year, however worked hard to increase my marks in the Trial examinations to make up for my poorer performance throughout the year.

Question 3

Which section/topic of the syllabus did you find most challenging?

English Advanced: Module C, Representation and Text – Conflicting perspectives; mainly because I had not done this module in Year 11 and it was therefore completely new to me.

English Extension One: Creative writing; the subjectivity of marking in creative writing made it difficult for me to write a story that satisfied the criteria in the syllabus.

English Extension Two: Critical Analysis; the sophistication and level of research involved in the formulation of my Major Work was quite challenging.

Mathematics: Probability; it was one of the later topics that I found difficult to wrap my head around.

Mathematics Extension One: Parametrics and Projectile Motion; some of the questions in these topics were particularly challenging.

Economics: Case Study; the enormous amount of information necessary in a Case Study made it a challenging topic.

Legal Studies: Focus Study: Family; the changing nature of the law in Family made it difficult to remain up to date with the legislation and cases.

Question 4

How much time did you spend preparing/working on school assessments?

English Advanced: I began organising my information and writing a practice essay about 2-3 weeks before an assessment to allow adequate time for the teacher to look over my work.

English Extension One: I began organising my information and writing a practice essay about 2-3 weeks before an assessment to allow adequate time for the teacher to look over my work. I also wrote several creative writing pieces to ensure adequate preparation for any stimulus.

English Extension Two: I began preparing for assessments about 2 weeks before.

Mathematics and Mathematics Extension One: I generally started doing past papers about 2-3 weeks before an assessment to allow time to ask my teacher questions.

Economics: I began memorising information about 3-4 weeks before an assessment and continually looked for new statistics.

Legal Studies: I began memorising information about 3-4 weeks before an assessment, continually on the lookout for cases, media articles and statistics.

Textbook, school teachers, tutors and internet.

Detail what you did differently between the two subjects and if applicable, provide your opinion on why you obtained such different scores.

My highest mark (97) was attained in Mathematics and Legal Studies whilst my lowest mark (47 = 94) was attained in Extension One English and Mathematics. My keen interest in Legal Studies made it easy for me to continue researching and studying the topic materials, solidifying and extending the material covered at school. I also particularly enjoyed Mathematics as I found it to be fairly straight forward and thus revised the work a lot. I had particular trouble grasping concepts in Extension One Maths which made me feel like giving up, negatively impacting my study time for the subject. Lack of planning in the HSC examination for Extension One English impacted my mark as I was not adequately prepared for my creative writing piece.

Question 13

As part of your HSC/TRIAL exam preparation for this subject, did you spend time writing up a comprehensive set of notes from which to learn? If yes, how many hours do you believe you invested into this task?

I would have spent about 30-40 hours writing notes for Economics and about 20 hours writing notes for Legal Studies. I did not write notes for other subjects.

English Advanced and Extension One: I would have worked through 5-6 past papers.

Mathematics Advanced: I would have done about 10-15 papers in the lead up to the HSC exams.

Mathematics Extension One: I would have done about 10 papers.

Economics and Legal Studies: I would have done about 3-4 past papers each.

I mainly worked through HSC exam papers for each subject, however acquired other schools' past papers from school. I also did many of the Catholic Schools' examination papers.

English Advanced and Extension One: about 2 weeks memorising essays.
Mathematics and Extension One: the equivalent about 4-5 weeks.
Economics: 3-4 weeks
Legal Studies: 3-4 weeks*

I found that the trial examinations were more difficult, mainly because it was the first set of exams in which I had all of my exams within 2 weeks and exactly as they would be in the HSC.

*English: I was not prepared for the requirement of "one related text" in Belonging. However, I had enough knowledge on the one related text to sustain half of an essay; therefore I did not panic as much as many did.
