Inventory recording using the FIFO and Identified Cost methods, distinguishing between product and period costs and the application of the Lower of Cost and Net Realisable Value rule. Preparing the Income Statement, Balance Sheet and Statements of Cash Flows. Ethical considerations and financial analysis.

Recording & reporting financial data Using a double entry accrual-based system, recording & reporting balance day adjustments (both expenses & revenues), the purchase & disposal of non-current assets, different methods of depreciation, analysing budgeted accounting reports & variance reports & the effect of alternative strategies on the performance of a business, as well as the ethical considerations of business owners when making decisions, including financial, social & environmental.

Business Foundations: Types of businesses & their objectives, stakeholders; their characteristics & potential conflicts, management styles & the appropriateness of each style in relation to the nature of a task & employee involved, management skills, their features & relationship to management styles & corporate culture.

Reviewing Performance - The Need for Change: Business change, proactive & reactive approaches to change, using KPI's to analyse the performance of businesses, the Force Field Analysis theory (Lewin), driving & restraining forces for change in business, strategic management according to Porter's Generic Strategies. Implementing Change: The importance of effective management strategies & leadership in change management; management strategies to respond to KPI's &/or seek new business opportunities, corporate culture & strategies for its development, the Learning Organisation (Senge), high & low risk strategies to overcome employee resistance, the Three-step Change Model (Lewin), the effect of change on stakeholder groups, incorporating corporate social responsibility into the change process, reviewing KPI's to evaluate the effectiveness of business transformation.
